Why?

As in other regions of BC, the forest resources sector in Skeena Region is challenged with wood residue disposal issues. With continuing restrictions on open burning, the shutdown of Tier 1 beehive burners and the cost of transportation, feasible alternatives for disposal or use of wood residue are very limited.

With a global move towards the development of a more sustainable environment and economy and the current push for green energy alternatives, the timing is right to sponsor a workshop focussed on better use of our wood residue resources.

What?
