### *Financial Sponsors*

The process for developing the Clean Air Plan and implementation of core programs related to airshed management such as Custom Venting Index Forecasting and the Skeena-BVLDD Woodstove Exchange Program was made possible by the financial contributions of a broad range of partners. The Ministry of Environment contributed \$180,000 and the North American Fund for Environmental Cooperation contributed \$40,000. Together, Pacific Inland Resources, Canfor, Houston Forest Products, Decker Lake Forest Products, Babine Forest Products, Newpro and Cheslatta Forest Products contributed \$25,000. The BC Lung Association contributed \$3,000 to the budget as well. All together, the total budget for the planning process was \$248,000 for 2003-2004.
